LIMITED WARRANTY

1. **CHAMPION WOOD** warrants, subject to the conditions and restrictions contained below, that each **CHAMPION WOOD** door manufactured and sold by **CHAMPION WOOD** will be free from defects in materials and workmanship for a period of:

	Interior Doors	Exterior Doors
Paint Grade Doors (factory primed)	5 years	2 years
Paint Grade Doors (not primed)	1 year	None
Stain Grade Doors	5 years	None

from the date of shipment or delivery.

2. Should a **CHAMPION WOOD** door fails to conform to this written warranty, **CHAMPION WOOD** will, at its option, either repair or replace the door, in the same condition of fitting or finishing as the door was originally sold, or refund the original purchase price paid to **CHAMPION WOOD** for such door.

3. The following will not be considered defects in material or workmanship and are not covered by this limited warranty:

3-1. Warp:
For doors up to 1-3/4" x 3/0 x 7/0: Not in excess of 1/4".
For doors up to 1-3/4" x 3/0 x 8/0: Not in excess of 3/8".
Warp will include bow, cup and twist and will be measured by placing a straight edge on the concave face of the door. The measurement will be at the point of maximum distance between the face of the door and the straight edge.
Doors over 1-3/4" in thickness, or over 3/0 in width, or over 8/0 in height, or any combination thereof, are not warranted.

3-2. Separation: Not in excess of 1/16".
Diagonal squareness measurements: Within (+/-) 1/8".
Thickness: Within (+/-) 1/16".
Width/Height: Within (+/-) 1/8".

3-3. Bow or nonalignment in the frame of jambs in which the door is hung.

3-4. Damage caused by others: Including but not limited to damage caused by misuse, abuse, accident or mishandling or by fire, flood, earthquake, storm, tornado, or other acts of nature.

3-5. Damage caused by failure to comply with the Care, Handling or Finishing Instructions provided by **CHAMPION WOOD**, failure to perform normal homeowner maintenance, or by attempts other than by **CHAMPION WOOD** to repair the door.

4. Claims under this Limited Warranty must be made in writing within the warranty period and prior to the beginning of any repair work to:

5. Claims should detail the following:
Date of purchase, Invoice Number, Line Item Number of the Door(s) Claimed, Nature of Defects, Name and Phone Number of the Person to Contact.

CHAMPION WOOD reserves the right and must be given at least a thirty (30) day opportunity to have any door which is the subject of a warranty claim filed inspected by a **CHAMPION WOOD** representative.

This limited warranty extends only to the original purchaser of a CHAMPION DOOR or the original purchaser of the structure into which such door is installed.

In no event will CHAMPION WOOD pay for the cost of labor, removal, installation, or finishing the replacement or original door or for any other cost relating to the replacement of the door.

6. Should a **CHAMPION WOOD** door fails to conform to this written warranty, **CHAMPION WOOD** will, at its option, either repair the door, or ship a replacement door to the distributor or person making the warranty claim in the same condition of fitting or finishing as the door which **CHAMPION WOOD** originally sold to the distributor, or refund the original purchase price paid to **CHAMPION WOOD** for such a door.

IN NO EVENT WILL CHAMPION WOOD PAY FOR THE COST OF LABOR, INSTALLATION OR FINISHING THE REPLACEMENT OR ORIGINAL DOOR OR FOR ANY OTHER COST RELATING TO THE REPLACEMENT OF THE DOOR, ALL OF WHICH WILL BE THE SOLE RESPONSIBILITY OF THE PERSON MAKING THE WARRANTY CLAIM.
